SUBJECT: New Training Session Dates

You have asked to be notified of the training dates for the Onsite Wastewater Practitioner Training Program. The Onsite Wastewater Practitioner Training Program is for those people wishing to obtain a PSDS Ticket in order to work in the Onsite Treatment System Industry. Successful certification in this program is now required by Alberta Municipal Affairs in order to obtain or apply for a current PSDS Ticket. This program is also accepted in British Columbia under the TILMA and the New West Partnership, in Saskatchewan under the New West Partnership and in Manitoba under the Agreement on Internal Trade.

The Installer Training Program is now a six-day course divided into two three-day sessions.

- You must complete all six days training successfully in order to receive certification.

If you are interested in being any of these training sessions, please complete the registration form which follows and fax it back. Space in the training sessions is limited and is allotted on a first come, first served basis. Upon receipt of the completed form and payment for training, your course supplies will be sent to you for review prior to training. **A minimum class of fifteen paid participants is required in order for the class to take place.**

Training fees must be received in our office prior to the course date.
